- **Once you become a member, your CVS ExtraCare Health Card (ECHC) will be mailed to you.** You will receive your ECHC card within 4-6 weeks. This card cannot be used to access your CareSource Advantage OTC benefit at the pharmacy.
- **As a new member, please allow seven days before using your OTC benefit.** For your first order, please call 1-866-292-5670 so that your account can be set up. From there you can either place the order online or continue to call into the CVS.com customer service line.

- **Locate your ExtraCare ID number on your CVS ExtraCare Health Card.** You must have your ExtraCare ID number to access your OTC benefit account.
- **Before you call or go online to order your OTC items,** make sure that you have your items identified.
- **Be sure to stay within your \$20 monthly benefit amount if you do not want to pay additional costs.** Should you go over your \$20 monthly benefit total, major credit cards (MasterCard, Visa, Discover and American Express) are accepted. Checks and money orders are not accepted.
- **Allow 7 to 10 business days for shipping.** Product specifications and prices are subject to change without notice.
- **Allow 30 days before placing your next order.**

IMPORTANT INFORMATION ABOUT USING YOUR OTC BENEFIT

You may only order items listed within the CareSource Advantage OTC catalog. Please see additional requirements below about using your OTC benefit:

- **Try to use your maximum benefit amount.** What you don't spend expires at the end of each month, and does not carry over.
- **Shipping is free when you order within your \$20 monthly benefit amount.** To avoid excessive mailing costs, please purchase a minimum amount of \$15 for each OTC order. A flat rate of \$5.49 is charged to you for any additional shipments that go over the \$20 monthly benefit amount.
- **If you receive a damaged product,** please call a CVS Customer Care Specialist immediately at **1-888-607-4CVS (4287)**. Please be prepared to provide the order number along with the reason for the return.
- **Prior to the purchase of a dual purpose product,** you must have appropriate conversations with your personal provider, and the personal provider must orally recommend the OTC item for a specific diagnosable condition.
- **Certain OTC items, not included in this catalog, may be covered under your Medicare Part B or Part D benefit.** Examples include smoking cessation aides and diabetic supplies. HOW TO USE THE OTC CATALOG

This catalog is organized into categories to help you find items quickly. Examples of these categories include **Pain Reliever/Fever Reducer**, **Vitamins and Supplements**, and **First Aid**. These categories are either dual purpose or eligible.

- **Eligible:** Items labeled “Eligible” can be ordered without discussing with your provider. Examples of eligible items include Fiber supplements, First Aid supplies, incontinence supplies, medicines, ointments, and sprays with active medical ingredients.
Note: All eligible items on the OTC list are covered under the OTC pharmacy benefit.
- **Dual Purpose:** To get items labeled as “Dual Purpose,” you must first discuss it with your provider. If your provider recommends an item for a specific condition, you may order the item through the catalog. Examples of dual purpose items include vitamins, minerals, and items to assist in weight loss, diagnostic equipment, and hormone replacements.
- **Non-Eligible:** There are some items not covered by the CareSource Advantage OTC benefit; these are “Non-Eligible.” If these items are purchased they will not be covered by CareSource Advantage. Examples of Non-Eligible items include: alternative medicines, baby items, contraceptives, non-medical convenience items, cosmetics, food supplements, and replacement items.
