# **D-SNP Updates**

As we continue to evolve, we are excited to share that the Health Needs Assessment (HNA) – *you may better know these as a Health Risk Assessment* – is now part of the CareSource DSNP enrollment process within Connecture. We received feedback this is functionality many agents have been asking for. Hooray for technology, gone are the fillable PDFs of yesterday!

• A reminder that for the remainder of 2024, CareSource offers our external sales agents \$150 for a completed HNA with the DSNP enrollment. Please share this with your DSNP sales agents.

SunFire was added to our family of DSNP enrollment portals last year. If you are utilizing SunFire for your Medicare enrollments, we ask that you reach out to SunFire and request access to CareSource's plan through the platform. You and your DSNP agents will not have visibility to our DSNP product until that partnership is set up.

# **CMS Medicare Regulations Updates**

Possible End Dates for the SEP for Government Entity-Declared Disaster or Other Emergency (§§ 422.62 and 423.38)

• This provision updates the SEP rules for individuals affected by an emergency or major disaster declared by a Federal, State or local government entity.

#### Revise Initial Coverage Election Period Timeframe To Coordinate With A/B Enrollment (§ 422.62)

CMS finalized the extension of the timeframe for an individual to elect MA when first eligible. Specifically, the rule allows an individual who newly enrolls in Part A and/or Part B beyond their initial Medicare enrollment period to elect to join an MA plan up to 2 months after the date they have both Part A and Part B coverage. Currently, a person who does not elect MA before the effective date of their Part A and B coverage generally must wait until the next enrollment period that is available to them to make an MA election.

## **Termed Agents**
